

## REVOCABLE LICENSE AGREEMENT

This License Agreement is made on the date set forth below by and between the Association of Physicians of Pakistani-Descent of North America, an Illinois not for profit corporation ("Licensor" or "APPNA" ) and the APPNA (NAME OF LOCAL COMMUNITY) Health Center, Inc., a (NAME OF STATE) not for profit corporation ("Licensee" or "Health Center").

### RECITALS

- A. Licensor is the owner of United States Trademark Registration No. 3,293,703 for the Service Mark "APPNA". APPNA uses this mark as a means of promoting the mission and purposes of APPNA and providing information via the Internet and other media regarding the activities and services of APPNA to its members and to the general public. APPNA's federal registration of its Service Mark has been in effect since September 18, 2007. Licensor has used "APPNA" in commerce since at least January 1991. Licensor also owns the domain name www.appna.org which is an operating commercial website;
- B. Licensee is engaged in the business of providing community health services and is supported and or its membership is primarily comprised of members of Licensor;
- C. Licensee and Licensor mutually agree that it would enhance the reputation and expand the impact of Licensor's mission and purpose if Licensee's operations are promoted as being associated with Licensor's organization; and
- D. Licensor, subject to certain restrictions, wishes to allow Licensee to use the name APPNA for its business of providing community health care services.

NOW, THEREFORE, for good and valued consideration, the receipt of which is here acknowledged, it is hereby agreed as follows:

- 1. Licensor hereby grants to Licensee a nonexclusive license including the right and privilege to use Licensor's Service Mark "APPNA" in its business providing community health care services;
- 2. The License granted by this Agreement shall be effective as of \_\_\_\_\_, and shall continue through an including \_\_\_\_\_, or the date that Licensor,

with or without cause demands Licensee to cease the use of the name “APPNA” in its name, whichever shall first occur.

3. The rights and privileges granted herein are not exclusive, and Licensor herewith reserves the right to use said name and at any time to grant other or similar privileges to use said service mark to additional parties.
4. Licensee agrees that it will maintain the use of the service mark “APPNA” in the spirit of, and in conjunction with, the philosophy, principals and good will practices of Licensor.
5. Licensee agrees that if the License is revoked by Licensor pursuant to this Agreement, that Licensee will immediately terminate the use of the service mark "APPNA” in any and all of its business, legal and other affairs and activities.
6. Licensee agrees, that if it fails to comply with any aspect of this Agreement, or if Licensor shall initiate any legal action pursuant to this Agreement, Licensee agrees to pay all of Licensor's damages and costs of enforcement, including reasonable attorney fees that Licensor may incur as a result of the breach of this Agreement or that Licensor may incur in order to enforce any of the provisions of this Agreement.
