	APPNA approval, exhibitor is subject to additional fee.

	(1) 8'-draped backdrop, (2) small 3'-draped dividers, (1) company I.D. sign, (1) 6' draped					
	display table, and (2) chairs, (1) trash can.					
15.	Full refunds, less \$300 cancellation fee, will be issued for cancellations made by exhibitors					
	prior to May 15, 2019.					
	A All credit card transactions are subject to a 3% NON-REFUNDABLE PROCESSING FEE.
