On Financial transparency, my self, Dr. Aftab Khan and Finance Committee is working on it. Audit process ahs been started for year 2018 and I vouch that we will get all financial issues settle for membership as soon as we can.

As the approval was done to transfer 50% of assets to another company, Finance Committee of last year has chosen Fidelity Investment and we are process of doing so.

This year the main project for APPNA under my presidency will be to invest in Pakistani-American and Pakistan's intellect. Our ultimate goal is to have incubator for innovation and research. We are looking into making an organization which will work on this and I hope we are successful. In this respect we met with Organization of Pakistani Entrepreneurs (OPEN) in Silicon valley to see if any collaboration can be done and it was quite a successful meeting with OPEN.

Advocacy committee is working hard on resident visa issues and already met with State Department and discussed the issues. One of the thing which we are interested in to promote Medicare for All and working with Rashida Tliab's office. One of my promise was to also get involve into our medical issues facing US population.

Day on the Hill will be held on May 1<sup>st</sup> 2019 and I urge all of you to attend and it will be an impactful program.

MERIT program, I an excited that we are getting help from Pakistan Pharma industry to promote our CME program in Pakistan and improve the tele-medicine program.

Our flagship Committee is Social welfare program including Cornea program, Cleft lip and Water program are continued and at present no new project are being done. APPNA has been instrumental in doing work all over the globe.
